

## Cost Share Guidelines

- ♦ Non-crop areas only
- ♦ Weed(s) may need to be verified by Weed & Pest prior to treatment
- ♦ Limit is \$2000/landowner
- ♦ Canal Districts are \$5,000 for large and \$1,000 for small
- ♦ Pesticides must be obtained through the Big Horn County Weed & Pest Office in order to receive cost share prices.

## Available Treatment Options

Big Horn County Weed & Pest District offers a cost share of 80% on labor and herbicide for Whitetop and Russian knapweed control. Call the office at anytime to be put on either one or both of these treatment lists. Charges will occur by treated acres only. Projects will be done on a first come, first served basis, weather conditions permitting.

## Cost Share Programs

## Whitetop

Cost Share Date  
*April 15—June 30*

80% cost share

**Escort or Telar - dry granular**

- \* Use 1 oz/acre  
or
- \* 1 gram/gallon of water

*A surfactant is highly recommended*

### Timing Recommendation

Non-crop applications are made early spring during the plants “broccoli” stage. Flowering dates are April—August. Affects are evident about 4-6 weeks after application. Herbicide carries a 3+ month residual.



## Russian olive / Saltcedar

Cost Share Date  
*NO DATE RESTRICTIONS*

50% cost share

**Element 4 and Bark Oil Blue**

- 3:1 ratio
- \* 3 parts Bark Oil Blue  
to
- \* 1 part Element 4

### Timing Recommendations

Non-crop applications are recommended with 3 options; Foliar, Cut Stump and Basal Bark treatments. These options are intended for the dormant season, but can be applied year round. Ideal temperatures should be between 20° F and 90° F. **Mixing required vigorous agitation to form an oil solution, then agitate every 4 hours.**



## Russian knapweed

Cost Share Date  
*August 1—November 15*

80% cost share

**Milestone— liquid**

- \* Use 6 oz/acre  
or
- \* 18 mL to 3 gallons of water

*A surfactant is highly recommended*

### Timing Recommendation

Non-crop applications are made at early flowering stages and to dormant plants in the fall. This aids in the movement into the roots which helps increase long-term control. Herbicide carries a 3+ month residual.

## Leafy Spurge & Priority Noxious Weeds

Priority Species cost share is 100% of labor and herbicide. These Priority Noxious Weed Species vary based on different State Designated and County Declared Noxious Weeds of Wyoming.

## Canal Districts

Canal Districts are offered a 50% cost share on labor and/or herbicide. *(Herbicides may vary based on requests for different noxious weeds to be treated).*

## AquaSweep

- ◆ 2.0 qts AquaSweep and 32 oz \*NIS / acre

### Timing Recommendations

Non-crop applications are recommended for foliar treatment only. Most effective from April through October. Best results are on smaller trees or suckers. **Every branch must be treated.**

**No more than 2 applications in a year.**

*\*NIS—Nonionic adjuvant, enhance herbicide activity without oils*

## Certified Weed Free Forage

Weed Free Forage cost share offers 50% on certified twine and tags at \$0.25 per tag. A certification inspection is \$15.00 per field. **Requests for certifications must be made a minimum of 5 days before and no more than 10 days prior to cutting.**

## Grasshoppers

Grasshopper cost share offered is a 50% on pesticides available. It is the responsibility of the landowner to apply products according to the label.
